# RISK ASSESSMENT – BOURLEY FLY FISHING CLUB (BFFC) – Bourley Lakes Version 2 dated August 2020

#### **SUMMARY**

This assessment has been complied for the Bourley Fly Fishing Club (BFFC) by the Secretary, to identify and mitigate the risks associated with the club's activities which consist of partaking in the sport of fly fishing from the lake bank.

#### **GENERAL AND COMMON AREAS OF RISK**

### Banks, Steps, Bridges

Always take care when negotiating the lake banks using steps, crossing bridges, wooden bridges can be slippery and potentially unsound. Additional care is necessary during wet and cold weather.

#### **Weather Conditions**

With all fishing and any outdoor activity, be constantly aware of changing weather conditions and its potential consequences. Strong winds make casting difficult and potentially dangerous. Avoid sunburn, wear sun block even when cloudy in the summer months and tinted glasses or sunglasses will help protect your eyes from glare.

During warm weather all members should ensure they have sufficient hydration with them to avoid the risk becoming disorientated due to de-hydration.

If there is a lightning storm in the vicinity, all members should cease fishing and put down their rods. Modern rods are a lightening conductor and holding a rod during a lightning storm is very dangerous and could cause a member to be struck by lightning.

#### **Protective Measures**

All members are recommended to wear suitable clothing when fishing including wearing either safety or sunglasses and a hat.

## **Duty of Care/Medical Conditions**

Remember that if you have any serious medical condition, physical disability or other such limitations, you MUST advise a Third party that you are going to fishing at Bourley. You are **strongly recommended** to carry a Medical aid card advising of what immediate aid action should be taken in the event of your having a medical emergency.

## **Disabled & Limited Mobility Members**

Members who are disabled or have limited mobility should act to be "buddied up" with someone close by at all times. Particular care should be taken when at the lake edges and areas where the ground is soft and uneven.

## Pandemic - COVID-19

Members will be advised separately of any special risks associated and precautions to be taken in the event of a pandemic including COVID-19.

## **General Risk Assessment**

Please note that this is a general risk assessment highlighting the majority of the potential problems/risks you are most likely to encounter whilst fly fishing. It's impossible to anticipate every single problem or potential risk and some circumstances can be totally unforeseen, accidents do happen, take care, move slowly and above all use common sense, much of the responsibility for your own safety lies with you.

## For the purposes of this Risk Assessment the lake has been divided into a number of zones as shown below:
